- **Option 3:** Only for New Admissions in current academic First Year and not having a Student ID: i) Admission confirmation letter from Institution; and ii) Secondary ID*

* Secondary ID: Driving license / Passport / Voter's ID / Aadhar (UID) / Photo Credit Card

Teachers:

This Apple Education Individual Proof completed and signed by the Education Individual plus the following;

- Employee ID card
- Secondary ID: Driving license / Passport / Voter's ID / Aadhar (UID) / Photo Credit Card

Reseller has the right to accept or reject your proof of status at its discretion. You agree to Reseller making a copy of this proof. Reseller will send it to Apple with this form where Apple will use it for the sole purpose of validating Your status as a Qualifying Individual.
